Divulgatium Corp., a corporation established under the laws of the State of Delaware, United States of America, hereinafter referred to as "THE PLATFORM",

The individual completing this form, hereinafter referred to as "THE COMMUNICATOR".

1. PURPOSE OF THE CANDIDACY

1.1. The Candidate formally requests to be considered for membership in THE PLATFORM as a Divulgator Senior Member, committing to create original and exclusive content in accordance with the terms outlined in this document.

2. REQUIREMENTS AND OBLIGATIONS OF THE COMMUNICATOR

- 2.1. Basic Requirements:
- Be of legal age according to the laws of the country of residence.
- Have the legal capacity to sign this agreement.
- Possess the knowledge and technical resources required to create high-quality audiovisual content.
- 2.2. Commitments of the Communicator:
- Upload at least 10 initial high-quality videos when starting their channel.
- Maintain a minimum frequency of 1 video per week during the first year.
- The content created will be exclusive to THE PLATFORM.
- The Communicator agrees to refrain from using inappropriate, offensive, or vulgar language in their videos.

3. COMPENSATION AND PARTICIPATION

3.1. Monthly Bonuses:

If accepted as a Divulgator Senior Member, the Communicator will receive monthly bonuses in DOCX Tokens as part of their participation in THE PLATFORM. These bonuses do not represent immediate payments but a donation of tokens that the Communicator may later redeem for actual shares in Divulgatium once the platform opens to the stock market.

- Amount: 100 DOCX Tokens per month.
- Initial Value: 1 DOCX Token = 10 USD.
- Frequency: Bonuses will be granted on the 5th of each month.
- 3.2. Conversion to Shares:

The DOCX Tokens granted as bonuses will represent future ownership in Divulgatium Corp. These bonuses can be converted into actual shares of the platform once Divulgatium opens to the stock market. The Communicator will become a co-owner of Divulgatium once these tokens are redeemed for shares.

3.3. Additional Conditions:

Once accepted as a Divulgator Senior Member, the Divulgator will receive an email with a definitive contract formalizing their acceptance. The Divulgator will not be required to make anyPágina / 2 2

initial payment upon becoming a Divulgator Senior Member. However, from the moment the Divulgator starts generating income through monetization or direct donations, a monthly fee of 10 USD will be deducted for the storage of their content. These costs will be allocated to thirdparty structures or providers responsible for the storage and management of the files.

4. CONTENT OWNERSHIP

- 4.1. The Divulgator retains the moral rights over the created content.
- 4.2. THE PLATFORM receives an exclusive license to use, distribute, and modify such content on its platforms.

5. CONFIDENTIALITY

- 5.1. The Divulgator agrees to maintain confidentiality regarding any technical, commercial, or other creators' information to which they may have access.
- 5.2. This confidentiality obligation will continue throughout the duration of the contract and for 5 years after its termination.

6. TERMINATION OF CANDIDACY

- 6.1. The Communicator may terminate this agreement at any time by mutual consent with THE PLATFORM.
- 6.2. In the event of a breach of the terms by the Communicator, THE PLATFORM may reject or terminate the collaboration and revoke any benefits granted.

7. DISPUTE RESOLUTION

- 7.1. In case of disputes, both parties agree to attempt to resolve them through direct negotiation for 15 days.
- 7.2. If no agreement is reached, they may resort to mediation and, if necessary, to binding arbitration.

8. APPLICABLE LAW AND JURISDICTION

- 8.1. This agreement will be governed by the laws of the State of Delaware, United States.
- 8.2. In case of disputes, jurisdiction will be in Miami, Florida, and the rules of the American Arbitration Association (AAA) will apply.
